Rules (PLEASE READ CAREFULLY FOR COVID GUIDELINES! Thank you for keeping our community safe):

- 1) Competition will be run in accordance with RSOBHD rules.
- 2) Age groups will be determined by entries received.
- 3) The decision of the judge is final.
- 4) Organizer reserves the right to modify schedule.
- 5) Dancers must arrive in costume, completed hair, and make-up.
- 6) Changing areas will not be available.

- 7) Each dancer **must** present a valid 2021 SDUSA registration card with the new sticker on the back. **Dancers without cards will not be allowed to dance.**
- 8) SDUSA Registration card must be in a zip lock bag when presenting at registration.
- 9) SDUSA requires all dancers at US competitions to wear face masks over their mouth and nose when they are not dancing on the competition stage. All dancers must wear their mask when they enter the competition stage. Dancers may remove their masks and place them in a paper bag placed at the back of the competition stage or opt to compete wearing the mask, whichever is more comfortable for the dancer. Dancers must wear their masks over their mouth and nose when they exit the competition stage.
- 10) Extra masks will be available for those who forget to bring a mask or face covering.
- 11) Hand sanitizer stations will be available throughout the venue.
- 12) A paper bags with handles will be provided upon arrival for holding the dancer's mask and a separate bag for SDUSA Registration card.
- 13) SDUSA "Day of Competition Certificate" will need to be signed upon arrival.
- 14) SDUSA assumption of risk form (adult or child) must be submitted with competition entry form for all attendees, including dancers, or filled out at arrival"
- 15) Only one dancer may register at a time and must practice social distancing while waiting in line.
- 16) Competition numbers will be issued in a zip lock bag.
- 17) The stage will not be available for warm-up. Dancer warm-up can be in either the designated family space or socially distanced outside the event perimeter.
- 18) Water will not be available; all dancers must provide their own water and snacks.
- 19) Awards will be placed in zip lock bags with the dancer's name and available for pickup at the awards table.
- 20) Trophy winners will be awarded on stage.
